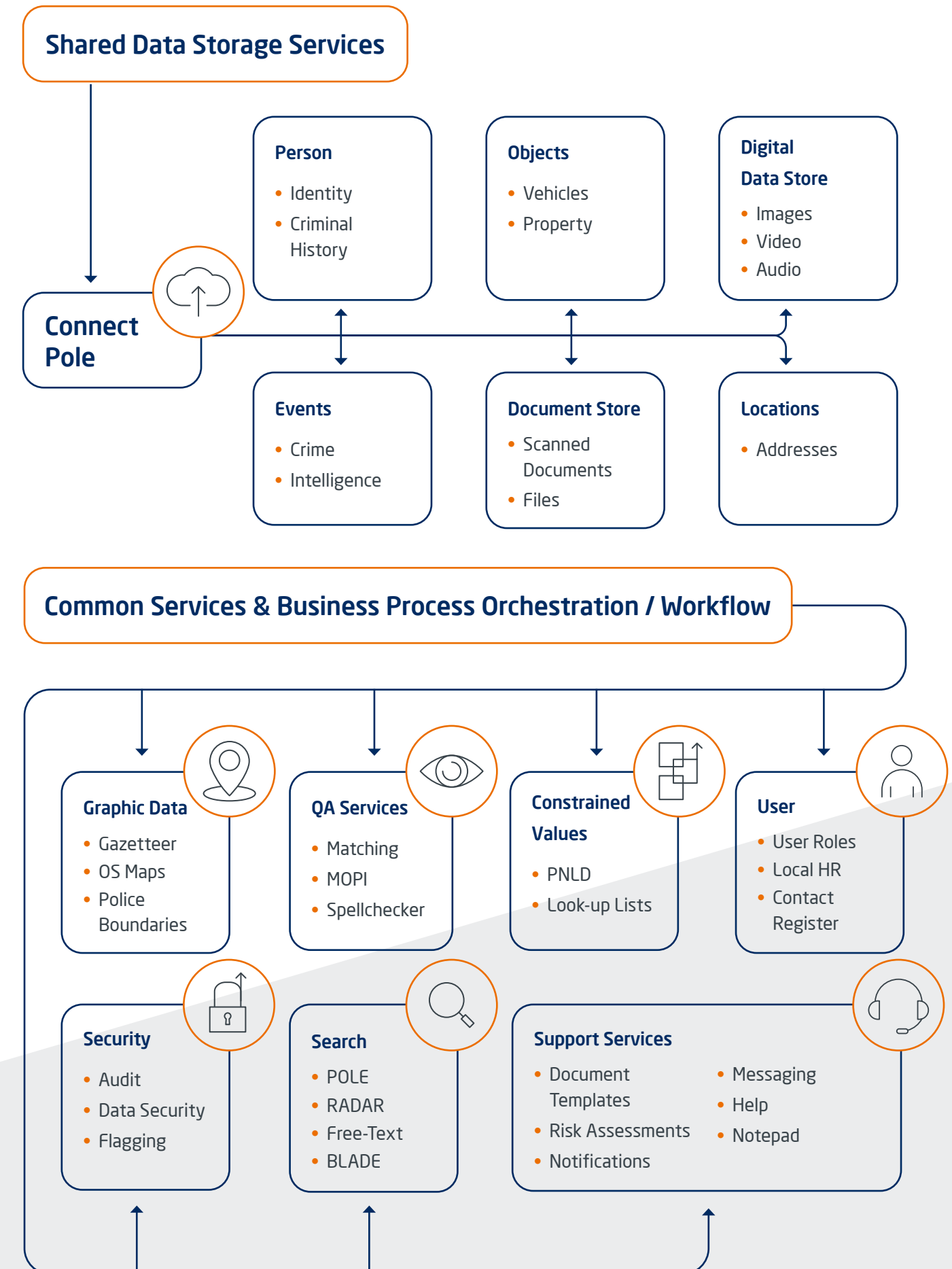
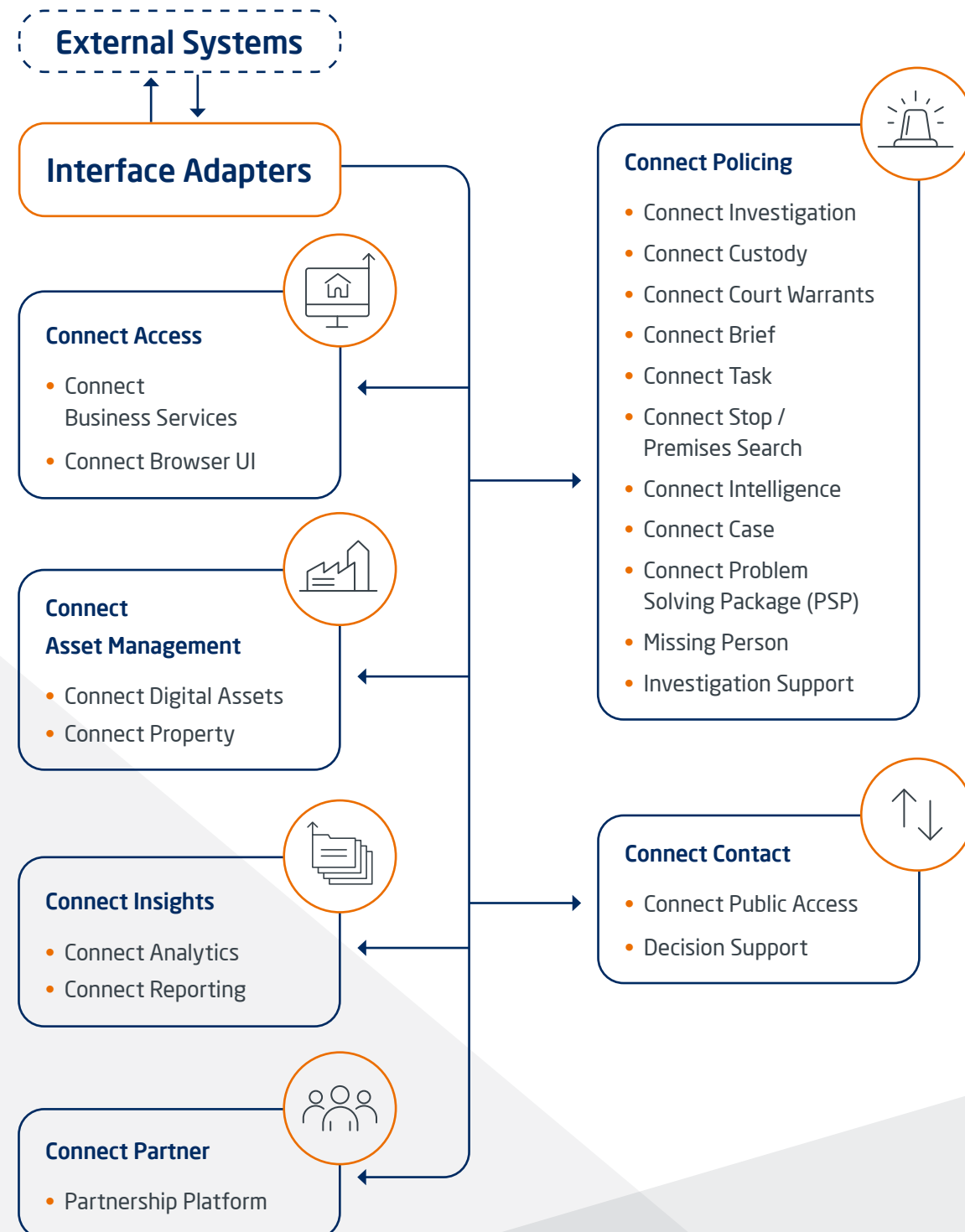

Investigations module

Connect Investigations enables you to record all crime and non-crime investigations in complete accordance with National Crime Recording Standards (NCRS) and the Home Office Counting Rules. A simple user interface guides users through the process of recording a crime and ensures a consistent quality record that meets minimum data standards. Connect integration ensures that there is never a need to duplicate data.

Key features in addition to the core Investigations module

Custody module

The Connect Custody module is a comprehensive solution for managing detainees and attendees, from arrival through to final offence disposal.

It's fully compliant with the processes and data capture requirements of PACE and (APP) guidance, and tightly integrated with other modules including Connect Case Management and Investigation and also external systems such as the Police National Computer (PNC).

Key features

- Delivers compliant police custody management of voluntary attendees and detainees, for both criminal and non-criminal offences
- Fully integrated, sharing key information across the other CONNECT policing modules including Intelligence and Crime Investigation, and case file preparation
- Delivers integration with PNC and liveScan, along with its own image-capture capabilities
- Linked case files support integrated file preparation and offence disposal through fully accredited Libra and two-way interfaces, enabling collaboration
- Part of an integrated system includes advanced notification capabilities to warn users where, for example, a detainee is already a known suspect for other crimes, on bail, wanted on warrant or subject to other flags
- Supports multi-force deployment, allowing forces across a region to collaborate
- Offers comprehensive system administration options to allow the solution to be customised to support local requirements.

Stop Search and Premises Search

The Connect Stop Search and Premises Search modules provide users with a mobile solution to record the details of persons or vehicles which are the subject of a stop search, and locations or vehicles which are the subject of a premises search following an arrest when a court-issued warrant has been granted.

The product is compliant with PACE and BuSS (Best use of Stop Search) and further integrated with Connect Property Management and Custody products and external systems such as PNC.

Seizing Property

Officers seizing property during a stop search can record details of the circumstances of the stop on a mobile device, the persons and / or vehicles stopped and the powers used to do so. Seized property is automatically associated with a person / vehicle it is seized from allowing the OIC to rescue the relevant information in a subsequent investigation.

Premises searches that are conducted as a result of an arrest, or the result of a Search Warrant that has

been granted, allow the OIC to record details of the premises searched and property subsequently seized relevant to the investigation.

The fully integrated Property Management solution allows evidential property seized during a Stop Search or Premises Search to be added to the Investigation and subsequently to the Case File as an exhibit or unused material without the need to re-key information that has already been captured.

Key features

- Mobile solution allowing the event to be recorded in situ
- Automatic linking allows seized property to be associated with the person / vehicle the object was seized from
- Automatic creation of property management event allows seized items to be managed by the OIC
- Integration with Investigation allows the OIC to view all property seized from Search events in one place.



Partner module

Connect Partner is a groundbreaking approach that allows agencies for the first time to collaborate using a secure police solution, but without the need for a police account or police IT hardware.

It creates in essence a virtual sharing platform powered by the police core record management solution. Partnerships and problem solving approaches therefore benefit from access to real-time police data and a range of Connect tools.

Key features

- Notification of events occurring in CONNECT related to the priority being managed. (Never miss key information again)
- Visualization of plans using Mapping, Timelines and Anacapa charts, highlighting a two-dimensional visual representation of linked data
- Granular Information sharing so you can choose what to share and with which partners
- Security infrastructure that means police data is persisted within a secure police network but visualised to partners outside that network
- Objectives, Tasks, Enquiry logs, Case Management, Action Plans, Reviews, Assessments.

How does collaboration in Connect set it apart?

Collaboration is key to reducing crime and protecting communities and vulnerable people. In 2018, the Home Office found information sharing between agencies was an issue in 76% of domestic homicide reviews. 43% of child serious case reviews in 2020 also identified information sharing between agencies as a factor in the death or serious injury of a child. Information sharing is however complex. For example up to 10 different systems will contain vital information for just one offender managed collaboratively.

The traditional approach to overcoming these challenges is through co-location and case management solutions that require double keying of data. Both approaches can act as a brake to information sharing with numerous recommendations and reports highlighting these barriers over the years. With the further challenges of budgetary restraint and COVID-19. Agencies require a capability that will more effectively support dynamic collaboration.

Property Management

Connect Property Management allows users to manage property objects that are recovered, seized or found during other processes such as a property seized during an investigation or search event, recovered from premises searched or found by a member of the public.

This module provides the officer in charge with the facility to manage property objects that have been seized or recovered during an Investigation, Stop Search, Premises Search or Custody detention.

The officer in charge is prompted periodically to review all property objects they are assigned to ensure their continued retention is necessary. A comprehensive transaction log is maintained, ensuring evidential integrity and management of all exhibits on a case file from the point they are seized through to disposal or long-term retention.

The property management event requires all objects to be sealed with a unique seal and allocated a storage location, all subsequent movements and seal updates provide a date, time and user audit trail.

Key features

- Allows management of property from seizure to disposal
- Integrated with other Connect modules: Custody, Stop and premises searches, Investigation, Forensics
- Property match notification
- Fully audited transaction log recording all: Movement, Seal application, Authorisation for disposal, Disposal, Ownership notification process
- PIN & signature capture
- Bulk transactions for objects belonging to multiple events.

Digital Assets

The Digital Assets module can be added to any event using a clever piece of functionality that we call 'Media Manager'. It makes it easy to upload and associate images, video files, documents and more with any event.

Digital assets are managed relevant to the event to which they are associated, for example CCTV which has been seized is managed relevant to the investigation and is retained as determined by the case file requirements.

It supports all investigations and case files that have digital evidence in addition to physical evidence. Digital evidence may be associated with physical evidence, for example the call or message logs of a seized mobile phone or digital images seized from a computer hard drive.

Key features

- Upload digital media to any Connect event: Images, Video files such as CCTV or BWV, Documents and PDF, Data downloads such as call / message logs
- Add hyperlinks and URLs to external data source such as evidence.com
- Assign exhibit references to digital assets.

Proactive Management Plans

Connect Proactive Management Plans (PMP) enables users to create a set of objectives and formulate action plans for a group of events, people or locations and then subsequently, at the finalisation stage of a PMP, an evaluation of the Connect Proactive Management Plans activities enable assessment of what worked well and what did not.

This learning provides value when managing similar events and developing objectives and action plans in the future.

A particular set of investigations can be grouped together to create a specific PMP to manage them holistically.

Key features

- The range of dates over which the PMP runs
- A clearly identified owner that can be a person or a team
- A set of objectives that the activities covered in the PMP aim to achieve
- An action plan made up of actions that can be allocated to teams or staff members to achieve the objectives
- A decision log to capture strategic, tactical and operational decisions that have been made
- A record of any expenditure that has been incurred and resources allocated to the PMP
- An evaluation of how effective the activities relating to the PMP have been including any lessons learned

- IOM (Integrated Offender Management)
- ASB (Anti-Social Behaviour)
- Troubled Families
